The San Diego Civic Dance Company is a performing troupe of dancers ranging in age from 12 to 20 years. The Company represents the City of San Diego at public concerts, benefits, conventions, and community events, while continuing their advanced training. Many Company members have joined local dance companies, as well as appearing in musical theater companies throughout southern California, and several have graced stages in the national scene.

To audition, each student must complete the 8-week intensive workshop which culminates in an audition for the Company. During the workshop, dancers will be polishing their tap, jazz, ballet and contemporary technique. Instructors will analyze each student's readiness to move to the level of study necessary to join the Company.

- Turning 12 by August 31, 2026. Age must be verified.
